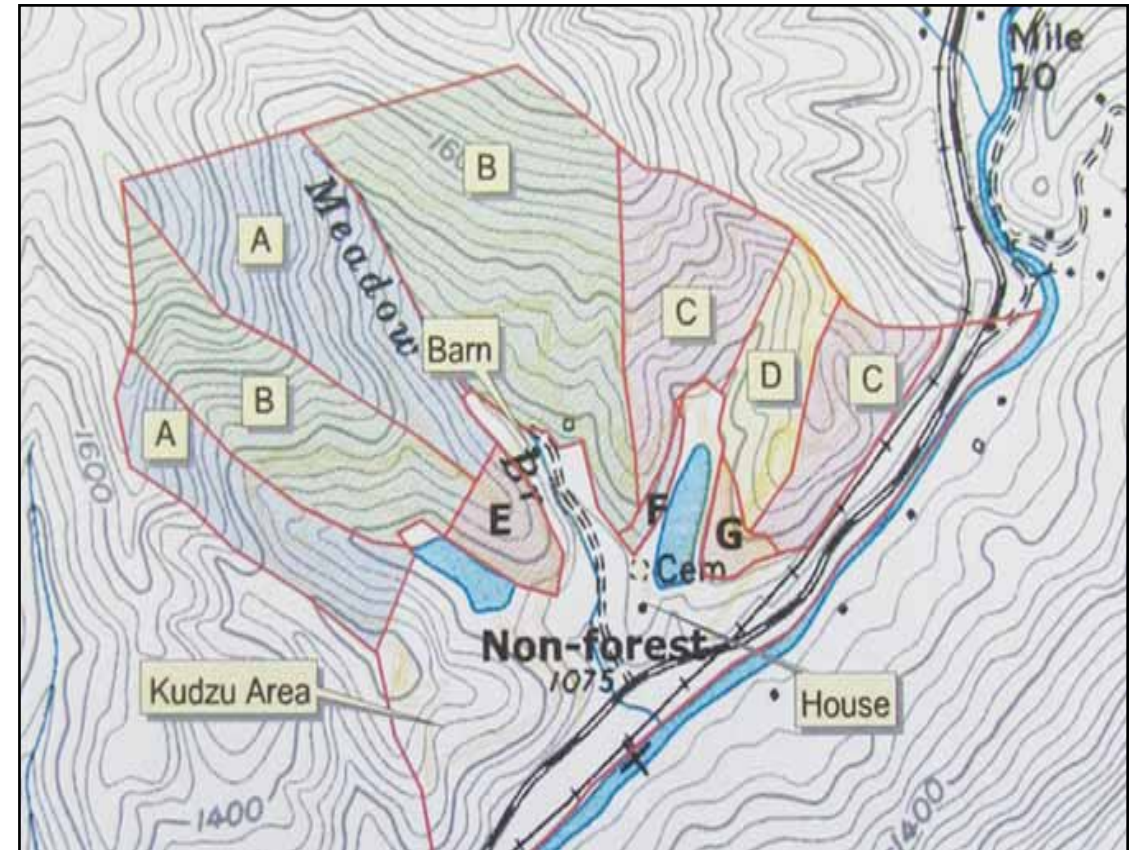

PROGRAM EMPHASIS

FORESTRY EDUCATION

- Statewide field days and other educational meetings
- Promote forestry education through woodland owner field days
- Encourage and support the formation of local forestry organizations
- Provide a scholarship for University of Kentucky forestry students

FOREST HEALTH

- Support KWOA initiated state level Forest Health Task Force
- Address control of invasive vegetative species, insect problems, and diseases
- Support educational programs to prevent forest fires and to prevent timber theft and unlawful trespassing

FOREST ECONOMY

- Fairness in timberland taxes
- Farm owner insurance policies that do not discriminate against tree farmers
- Support woodland certification efforts in order to improve market for raw wood products
- Better and more current log and raw wood price information

SERVICES OF KWOA

- Quarterly newsletter
- Two day annual meeting that rotates among Kentucky Resort Parks. The meetings include: hands-on field demonstrations and other educational programs
- Co-sponsor multiple field days and training events across the state
- Maintain informational web site, www.kwoa.net

- Appear before Legislative Committees addressing forest policy and funding issues.

- Provide opportunities for direct interaction with experienced woodland owners to exchange information, knowledge and ideas.
